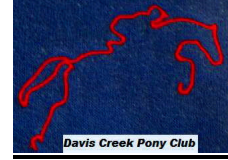

Awards and General Information:

- USEA Eventing Rules for Combined Tests will apply unless otherwise stated.
- Six ribbons in each division.
- All Children's Musical Freestyle division (D1) entrants will ribbon. A HUGE smile when leaving arena is our objective! Enter dressage arena when music begins and exit when music ends. Assistance is permitted. A helmet that fits is required. D1 division entrants may ride same horse as entered by another competitor in another division.
- Dressage Tests can be found at www.daviscreek.ponyclub.org and each test should be ridden from memory.
- Starting times available October 8, 2008 at www.daviscreek.ponyclub.org
- Negative coggins dated on or after 10/13/2007 required with entry.
- Dress: Casual, boots, breeches, ASTM approved helmet. Braiding/coats not required.
- Medical arm bands required for all jumping warm ups and phases of competition.

Entry Fees:

- Combined Test: \$40 per division or \$60 for two divisions (same horse/rider combination); Dressage divisions: \$20. Special Musical Freestyle \$5. Pony club member discount for any division entered: \$5.
- Refunds: before closing – full, after closing date – none. All competition & warm-up areas are under roof.

Facilities:

- 218 permanent onsite stabling: \$25/stall Sat night thru Sunday show. Sawdust available for use as bedding. Rustic Oak stalls with full doors. Wash areas available. Large gravel parking lot.
- Concessions on site. Electric hook ups for campers (additional fee). Showers in restrooms.
- All dressage in small arena set up within fenced, sand/dirt covered arena.
- All Stadium Jumping within large fenced, sand/dirt, covered arena.
- Winfield Riding Club address: 9254 State Route 34, Winfield, WV 25213
- Directions: The Winfield Riding Club showgrounds is located 5 miles off I-64 on Rt 34 between Huntington and Charleston WV. Traveling East or West on I-64, take exit 39 - the Teays Valley/Scott Depot Exit and travel South on Rt 34 towards Winfield. The show grounds are on the left just before the intersection of Rt 34 and Rt 35.
- Hotel Accommodations all are available 5 miles from Winfield Riding club at I-64
