<b>Starter</b>	<b>Dressage:</b> 2006 USEA Beginner Novice Test B <b>Cross Country:</b> 8-10 fences, max 2'; not timed <b>Stadium Jumping:</b> 6-8 vertical jumps 2'-2'3"; open grass field
<b>Beg Novice</b>	<b>Dressage:</b> 2006 USEA Beginner Novice Test B <b>Cross Country:</b> 10-12 fences max 2'7"; speed 300 mpm <b>Stadium Jumping:</b> 8-10 jumps max 2'6"; open grass field
<b>Novice</b>	<b>Dressage:</b> 2006 USEA Novice Test B <b>Cross Country:</b> 10-12 fences max 2'11" speed 350 mpm <b>Stadium Jumping:</b> 10-12 jumps max 2'11"; open grass field

**Combined Test Divisions:**

<b>Green</b>	<b>Dressage:</b> USDF Walk Trot Test B <b>SJ:</b> 6-8 x-rails max 18"; confined area, fenced grass or indoor
<b>Starter</b>	<b>Dressage:</b> 2006 USEA Beginner Novice Test B <b>Stadium Jumping:</b> 6-8 vertical jumps 2'-2'3"; open grass field
<b>Beg Novice</b>	<b>Dressage:</b> 2006 USEA Beginner Novice Test B <b>Stadium Jumping:</b> 8-10 jumps max 2'6"; open grass field
<b>Novice</b>	<b>Dressage:</b> 2006 USEA Novice Test B <b>Stadium Jumping:</b> 10-12 jumps max 2'11"; open grass field
<b>Training</b>	<b>Dressage:</b> 2006 USEA Training Test B <b>Stadium Jumping:</b> 10-12 jumps max 3'3"; open grass field

### **General Information**

- Dressage Judge: Kelly Hall.
  - Six ribbons in each division.
  - All dressage in small arena. Sand or grass depending on weather conditions.
  - Refunds: before closing – less \$20 office fee, after closing date – none
  - Starting times available July 6 at [www.daviscreek.ponyclub.org](http://www.daviscreek.ponyclub.org)
  - Entry Fees: Horse Trial \$65; Combined Test \$40;
  - Limited Stabling available Sat night: \$25.
  - Negative coggins dated on or after 7/13/2007 required with entry.
  - Dress: Casual, boots, breeches, ASTM approved helmet.
  - Medical arm bands required for all jumping warm ups and phases of competition.
  - Davis Creek Pony Club Horse Trial T-Shirts should be pre-ordered to ensure you get one in your size! Your shirt will then be included in your HT/CT packet.
