They are dedicated to the education of young riders and have allowed us to offer this clinic at a fraction of the typical clinic cost. Eric and Sara work out of Overlook farm North in Virginia and Overlook Farm South in Florida. Their qualifications as clinicians are too extensive to list here! This clinic is being offered to the 265 Midsouth Pony Club members rated D3 and above (out of 638 Midsouth members). The clinic fee is only \$120 for 3 - 1.5 hour sessions across 2 days. Limited stabling is available near Flying Cross for an additional \$25/night/horse.

Clinic participation will be distributed among the 28 clubs in the region and then prioritized by rating level, followed by postmark to fill the available 40 clinic spots from the waiting list.

A single clinic rider can use multiple horses if desired. There is plenty of parking available and the facilities are excellent. Riders travel from hundreds of miles to school their beautifully maintained XC courses.

Midsouth and USPC will continue to work with the USEA/ICP program instructors to present additional clinics in the future and include more of our membership.

Members/parents should complete and send in the entry for the clinic directly to the clinic secretary. Current Midsouth rating records will be referenced to ensure no one has a typo as to their current rating level! Please submit your completed clinic entry and negative coggins for each horse to:

You will be notified via email as to your entry status by July 2nd and clinic ride times will be posted on the Midsouth Pony Club Web Site. No checks will be deposited before the closing date and then only deposited if you were accepted into the clinic. Please remember a veterinarian's health certificate within 30 days is required for horses traveling in Kentucky. This clinic is 3 weeks after regional rally, so you could note both destinations/dates on the single certificate.

Our region has: 2-A,1-B,2-H,3-HB,6-HA,38-C3,53-C2,80-C1,70-D3

In order to ensure a quality clinic, each session will be limited to no more than 4 riders and with riders/horses at a comparable level. Each rider accepted into the clinic will ride in one Dressage and one Stadium clinic on Tues and one cross country clinic on Wed. In addition, a session on walking and planning your XC ride is planned after dinner on Tuesday.
